WHAT IS THE **GLOBAL POOL?**

Global Pool is an innovative platform that enables the automated and secure creation of USDT liquidity pools.

Through a partnership with Uniswap, all liquidity is created on the world's largest DEX, ensuring exceptional security and high liquidity.

The platform offers automatic rewards and self-custody, allowing users to track their liquidity positions in real time with full transparency.

CHARACTERISTICS OF MPOOL



Protocol: One of the largest and most respected on the Polygon network.

Deflation: A supply reduction system is implemented through token burns, increasing the asset's value over time.

Liquidity: Our pools have a 999-year lock managed by UNCX, ensuring stability and trust.

Supply: 100% circulating in the market, ensuring full accessibility.

Protection: Strong anti-whale mechanisms to protect all investors.

Liquidity Mechanism: The largest pool-creation system on the market, designed to meet growing demand.

Market Trend: Stable growth chart with strong upward potential.

HOW POOL CREATION WORKS

Minimum Values:

Pools can be created in multiples of \$10 in USDT on the Polygon network, allowing anyone to participate.

Automatic Profit:

When a purchase of MPOOL is generated, the tokens are automatically placed into liquidity, offering an average profit of 7%. For example, if a position is created with \$1000, the tokens will be sold for \$1070.

ADVANTAGES OF CREATING LIQUIDITY POOLS



Automation:

The creation and management of pools is fully automated, allowing users to save time and focus on their investment strategies.

Accessibility:

Global Pool democratizes access to liquidity markets, giving low-capital users the ability to participate.

Profit Opportunity:

Users can earn passive profits while their tokens remain in liquidity, increasing their return potential.

Transparency:

All data and operations are displayed in real time, promoting trust and providing a safe environment.

OPTIONS FOR REMOVING LIQUIDITY

ORANGE BUTTON BACK OFFICE

Allows liquidity removal at any time quickly and easily.

If liquidity is at 100%, the MPOOL is automatically sent to the user's wallet for total convenience.

GREEN BUTTON CLAIM

Available when the liquidity pool reaches 100% in USDT.

The principal amount is sent to the user's wallet along with 50% of the profit.

The remaining 50% is allocated to network bonuses, following the bonus rules so everyone benefits.

BLUE BUTTON REINVESTMENT

Activated when the liquidity is 100% in USDT.

100% of the principal amount goes to the market to buy MPOOL, ensuring continuous appreciation.

75% of the profit from the entry is used to buy MPOOL, creating a new position with 7% appreciation.

The remaining 25% of the profit is sent to the network bonus following the same claim rules.

LEVEL STRUCTURE

PROFIT DISTRIBUTION

1ST LEVEL

30% \$10

To unlock this level, the user must have an active pool of at least \$10 and one direct referral active with \$10.

2ND LEVEL

15% \$20

Requires an active pool of at least \$20 and two direct referrals active with \$10.

3RD LEVE

7% \$30

Requires an active pool of at least \$30 and three direct referrals active with \$10.

4TH LEVEL

7% \$40

Requires an active pool of at least \$40 and four direct referrals active with \$10.

5TH LEVEL

7% \$50

Requires an active pool of at least \$50 and five direct referrals active with \$10.

6TH LEVEL

7% \$60

Requires an active pool of at least \$60 and six direct referrals active with \$10.

7TH LEVEL

7% \$70

Requires an active pool of at least \$70 and seven direct referrals active with \$10.

8TH LEVEL

5% \$80

Requires an active pool of at least \$80 and eight direct referrals active with \$10.

9TH LEVEL

5% \$90

Requires an active pool of at least \$90 and nine direct referrals active with \$10.

10TH LEVEL

5% \$100

Requires an active pool of at least \$100 and ten direct referrals active with \$10.

11TH LEVEL

1% \$110

Requires an active pool of at least \$110 and eleven direct referrals active with \$10.

12TH LEVEL

1% \$120

Requires an active pool of at least \$120 and twelve direct referrals active with \$10.

13TH LEVEL

1% \$130

Requires an active pool of at least \$130 and thirteen direct referrals active with \$10.

14TH LEVEL

1% \$140

Requires an active pool of at least \$140 and fourteen direct referrals active with \$10.

15TH LEVEL

1% \$150

Requires an active pool of at least \$150 and fifteen direct referrals active with \$10.

RULES TO MAINTAIN ACTIVITY

To unlock levels, users must have an active pool that matches the minimum value required for each level.

Users must follow the referral rules: each level requires a minimum number of active direct referrals.

To remain active, the user must have at least one active pool above \$10.

If the required number of active referrals is not met, the user becomes ineligible to receive bonuses.

All direct referrals must be active for the corresponding levels to count.





THE ROLE OF LIQUIDITY

Liquidity is essential for efficient cryptocurrency transactions. A liquid market provides efficiency and security in trade execution.

The average daily trading volume in September 2025 is around \$80 billion, reflecting constant growth, especially across decentralized exchanges, where Global Pool stands out.

GROWTH OF LIQUIDITY POOLS

Liquidity pools allow users to provide liquidity in exchange for rewards, playing a crucial role in the operation of DEXs.

Uniswap, one of the largest DEXs, recorded approximately \$6 billion in TVL in 2025, reflecting strong market confidence and growth opportunities.
